INSTRUCTIONS FOR COMPLETION OF PROXY

1. Each Proven Unsecured Creditor who has a right to vote at the Creditors' Meeting has the right to appoint a person (who need not be a Proven Unsecured Creditor) to attend, act and vote for and on behalf of the Proven Unsecured Creditor and such right may be exercised by inserting in the space provided the name of the person to be appointed.
2. **If no other person is named as proxy in the space provided above, David Bowra of The Bowra Group Inc., in its capacity as Monitor, or such other representative of the Monitor as Mr. Bowra may designate, shall be deemed to be appointed as proxyholder for the Proven Unsecured Creditor, with power of substitution.**
3. **If an officer of The Bowra Group Inc. is appointed or is deemed to be appointed as proxyholder and the Proven Unsecured Creditor fails to indicate on this Proxy a vote for or against approval of the Plan, this Proxy will be voted FOR approval of the Plan.**
4. If this Proxy is not dated in the space provided, it shall be deemed to be dated on the date it is received by the Monitor.
5. This Proxy must be signed by the Proven Unsecured Creditor or by the Proven Unsecured Creditor's attorney duly authorized in writing or, if the Proven Unsecured Creditor is a corporation, by a duly authorized officer of attorney of the corporation with an indication of the title of such officer or attorney.
6. Valid proxies executed by the Proven Unsecured Creditor and bearing or deemed to bear a later date shall revoke this Proxy. If more than one valid proxy for the same Proven Unsecured Creditor and bearing or deemed to bear the same date are received with conflicting instructions, such proxies will be treated as disputed proxies and shall not be counted.
