**NOTICE OF APPLICATION**

**Name of applicant:** RMK Investments Inc. ("RMK")

To: the Service List, attached as **Schedule "A"**

TAKE NOTICE that an application will be made by the applicant to the presiding judge or master at the courthouse at 800 Smithe Street, in the City of Vancouver, in the Province of British Columbia on Thursday, March 7, 2019 at 9:45 a.m. for the order set out in Part 1 below.

**Part 1: ORDER SOUGHT**

1. An Order approving the Proposal (as defined below) filed by RMK on January 11, 2019 and accepted by the creditors at a meeting held on Friday, February 1, 2019 or in the alternative, adjourning generally the application for such Order

**Part 2: FACTUAL BASIS**

1. On October 30, 2018, RMK caused a Notice of Intention to Make a Proposal to be filed, pursuant to section 50.4(1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as amended (the "BIA").
2. On the same date, The Bowra Group Inc. was appointed proposal trustee (the "Trustee").
3. On November 28, 2018, RMK applied for and was granted an extension of time to make a proposal to its creditors, with that extension expiring on January 13, 2019.
4. RMK filed a proposal to its creditors on January 11, 2019 (the "Proposal").
5. The Proposal was approved by the requisite majority of creditors of RMK at the meeting of creditors held on February 1, 2019.

6. It is the opinion of the Trustee that the terms of the Proposal are fair and reasonable, that the Proposal has been submitted to RMK's creditors in good faith and with due diligence, and that RMK has the financial resources to complete the Proposal in accordance with its terms.
7. The Trustee has requested that Norton Rose Fulbright Canada LLP, as counsel for RMK, make this application before the Court for approval of the Proposal in order to minimize costs as the Trustee has not retained counsel in these proceedings.

**Part 3: LEGAL BASIS**

1. Part III, and in particular, sections 58 and 59 of the BIA; and
2. the inherent jurisdiction of this Court.

**Part 4: MATERIAL TO BE RELIED ON**

1. Report of the Proposal Trustee, to be filed;
2. The proceedings and pleadings herein; and
3. Such further and other material as counsel may advise and this Honourable Court may accept.

The applicant estimates that the application will take 5 minutes.

This matter is within the jurisdiction of a master (in his or her capacity as a Registrar in Bankruptcy) if the application is not opposed: BIA section 192(1)(d). However, if the hearing is opposed then a master does not have jurisdiction to hear the application, and it must then be heard by a judge.

**TO THE PERSONS RECEIVING THIS NOTICE OF APPLICATION:** If you wish to respond to this notice of application, you must, within 5 business days after service of this notice of application or, if this application is brought under Rule 9-7, within 8 business days after service of this notice of application,


- (a) file an application response in Form 33,

  - (i) you intend to refer to at the hearing of this application, and
  - (ii) has not already been filed in the proceeding, and
- (c) serve on the applicant 2 copies of the following, and on every other party of record one copy of the following:
  - (i) a copy of the filed application response;

- (ii) a copy of each of the filed affidavits and other documents that you intend to refer to at the hearing of this application and that has not already been served on that person;
- (iii) if this application is brought under Rule 9-7, any notice that you are required to give under Rule 9-7 (9).
