Performance Ag Group Calmar Ltd., Har-De Agri Services Ltd. ("Har-De"), and 1235962 Alberta Ltd. (collectively, the "Debtors") for an order: (i) approving the Offer made by Ritchie Bros. Auctioneers (Canada) Ltd. and Ritchie Bros. Real Estate Services Ltd. (the "Auctioneer") for the auction (the "Auction") of the Equipment listed in Schedule "B" hereto (the "Equipment") and the Lands listed in Schedule "C" hereto and as defined below (collectively with the Equipment, the "Assets"); (ii) authorizing the Receiver, in that capacity, to enter into a Contract to Auction (the "Contract") the Assets; and (iii) vesting the Debtors' right, title and interest in and to the Assets in any person or persons who purchase the Assets or any part thereof (a "Purchaser");

AND UPON HAVING READ the Receivership Order dated October 16, 2019 (the "Receivership Order"), the Notice of Application, the Second Report of the Receiver (the "Report"), and the Affidavit of Service, filed; AND UPON HEARING the submissions of counsel for the Receiver and any other interested parties appearing at the within application;

IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE

1. Service of notice of this application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of this application and time for service of this application is abridged to that actually given.

APPROVAL OF CONTRACT/MARKETING AND SALE OF ASSETS

2. The Contract is hereby approved and the Receiver is authorized and empowered to execute the Contract with such minor amendments as the Receiver may deem necessary. The Receiver is hereby authorized and directed to take any and all actions as may be necessary or desirable to implement the Contract and sell the Assets. Without limiting the foregoing, the Receiver is hereby authorized and directed to take such additional steps and execute such additional agreements, contracts, deeds or such other documents as may be necessary or desirable to complete any sale to a Purchaser of the Assets, or any part thereof.

- 3. The sales process relating to the Assets and all actions taken by the Receiver to date, as outlined in the Report, are hereby approved.
- 4. The Auction of the Assets is commercially reasonable and in the best interests of the Debtors and their stakeholders.

SALE AND VESTING OF THE EQUIPMENT

- The Auctioneer is authorized to market and sell the Equipment particularized in Schedule "B" to this Order in accordance with the terms of the Contract (the "Equipment Sales"). The Equipment Sales shall be free and clear of and from any and all caveats, security interests, hypothecs, pledges, mortgages, liens, trusts or deemed trusts, reservations of ownership, royalties, options, rights of pre-emption, privileges, interests, assignments, actions, judgements, executions, levies, taxes, writs of enforcement, charges, or other claims, whether contractual, statutory, financial, monetary or otherwise, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, "Claims") including, without limiting the generality of the foregoing:
 - (a) any encumbrances or charges created by the Receivership Order;
 - (b) any charges, security interests or claims evidenced by registrations pursuant to the Personal Property Security Act (Alberta) or any other personal property registry system,

collectively, the "Equipment Encumbrances".

- 6. Upon the Auctioneer completing the sale of any of the Equipment to a Purchaser (an "Equipment Purchaser"), and upon the Auctioneer's receipt of the full purchase price and delivery by the Auctioneer of evidence of the purchase to such Equipment Purchaser:
 - (a) all of the Debtors' right, title and interest in and to the Equipment shall vest absolutely in the name of the Equipment Purchaser (or its nominee) free and clear of and from any and all Claims, and all Equipment Encumbrances affecting or

- relating to such Equipment are hereby expunged, discharged and terminated as against such Equipment;
- (b) any Debtor and all persons who claim by, through or under such Debtor in respect of the Equipment, as applicable, shall stand absolutely barred and foreclosed from all estate, right, title, interest, royalty, rental and equity of redemption of the Equipment and, to the extent that any such persons remain in possession or control of any of the Equipment they shall forthwith deliver possession thereof to the Equipment Purchaser (or its nominee); and
- (c) the Equipment Purchaser (it is nominee) shall be entitled to enter into and upon, hold and enjoy the Equipment for its own use and benefit without any interference of or by any Debtor, or any person claiming by or through or against the Debtors.

From and after the sale of any of the Equipment to an Equipment Purchaser, the Receiver is authorized to take all such steps as may be necessary to effect the discharge of any security registration or registrations, including but not limited to those made at the Alberta Personal Property Registry, relating to Claims registered against the Equipment, including Equipment Encumbrances, whether made before or after the date of this Order, as may be necessary, provided that the Receiver shall not be authorized to effect any discharge that would have the effect of releasing any collateral other than the Equipment, and the Receiver shall be authorized to take any further steps by way of further application to this Court. All governmental authorities ("Governmental Authorities") are hereby authorized, requested and directed to comply with the discharge requests contemplated by this paragraph.

SALE AND VESTING OF THE LANDS

8. The Auctioneer is authorized to market and sell the Lands, as defined below, in accordance with the terms of the Contract. Upon delivery of a Receiver's certificate to the Purchaser (or its nominee) substantially in the form set out in Schedule "A" hereto (the "Receiver's Closing Certificate"), all of Har-De's right, title and interest in and to the land described in Schedule "C" hereto and as also described in paragraph 8(a)(i)

hereof (the "Lands") shall vest absolutely in the name of the Land Purchaser (as defined below), free and clear of and from any and all Claims, including:

- (a) any encumbrances or charges created by the Receivership Order;
- (b) any charges, security interests or claims evidenced by registrations pursuant to the Personal Property Security Act (Alberta) or any other personal property registry system;
- (c) any liens or claims of lien under the Builders Lien Act (Alberta); and
- (d) those Claims listed in Schedule "D" hereto (all of which are collectively referred to as the "Land Encumbrances", which term shall not include the permitted encumbrances, caveats, interests, easements, and restrictive covenants listed in Schedule "E" (collectively, "Permitted Land Encumbrances")),

and for greater certainty, this Court orders that all Claims including Land Encumbrances other than Permitted Land Encumbrances, affecting or relating to the Lands are hereby expunged, discharged and terminated as against the Lands.

9. Upon delivery of the Receiver's Closing Certificate, and upon the filing of a certified copy of this Order, together with any applicable registration fees, all Governmental Authorities including those referred to below in this paragraph are hereby authorized, requested and directed to accept delivery of such Receiver's Closing Certificate and certified copy of this Order as though they were originals and to register such transfers, interest authorizations, discharges and discharge statements of conveyance as may be required to convey to such Purchaser (or its nominee) as may enter into a binding agreement to purchase the Lands (the "Sale Agreement"), the identity of which Purchaser or nominee shall be directed by the Receiver's counsel (the "Land Purchaser") in correspondence (the "Receiver's Correspondence") addressed to the attention of the Registrar of Land Titles (the "Land Titles Registrar"), clear title to the Lands subject only to Permitted Land Encumbrances. Without limiting the foregoing:

- (a) the Land Titles Registrar shall and is hereby authorized, requested and directed to forthwith:
 - (i) cancel existing Certificate of Title No. 982 073 850 for the Lands, being those legally described as:

PLAN 8822207 LOT 1 EXCEPTING THEREOUT ALL MINES AND MINERALS AREA: 1.48 HECTARES (3.66 ACRES) MORE OR LESS

- (ii) issue a new Certificate of Title for the Lands in the name of the Land Purchaser (the "New Certificate of Title");
- (iii) transfer to the New Certificate of Title the existing instruments listed in Schedule "E", to this Order, and to issue and register against the New Certificate of Title such new caveats, utility rights of ways, easements or other instruments as are listed in Schedule "E"; and
- (iv) discharge and expunge the Land Encumbrances listed in Schedule "D" to this Order and discharge and expunge any Claims including Land Encumbrances (but excluding Permitted Land Encumbrances) which may be registered after the date of this Order against the existing Certificate of Title to the Lands:
- 10. In order to effect the transfers and discharges described above, this Court directs each of the Governmental Authorities to take such steps as are necessary to give effect to the terms of this Order and the Sale Agreement relating to the Lands. Presentment of this Order, the Receiver's Correspondence and the Receiver's Closing Certificate shall be the sole and sufficient authority for the Governmental Authorities to make and register transfers of title or interest and cancel and discharge registrations against the Lands of any Claims including Land Encumbrances but excluding Permitted Land Encumbrances.
- 11. No authorization, approval or other action by and no notice to or filing with any governmental authority or regulatory body exercising jurisdiction over the Lands is

required for the due execution, delivery and performance by the Receiver of the Sale Agreement.

- 12. Upon delivery of the Receiver's Closing Certificate together with a certified copy of this Order, this Order shall be immediately registered by the Land Titles Registrar notwithstanding the requirements of section 191(1) of the Land Titles Act, RSA 2000, c.L-7 and notwithstanding that the appeal period in respect of this Order has not elapsed. The Land Titles Registrar is hereby directed to accept all Affidavits of Corporate Signing Authority submitted by the Receiver in its capacity as Receiver of Har-De and not in its personal capacity.
- 13. Upon completion of the sale of the Lands, the Debtors and all persons who claim by, through or under the Debtors in respect of the Lands, and all persons or entities having any Claims of any kind whatsoever in respect of the Lands, save and except for persons entitled to the benefit of the Permitted Land Encumbrances, shall stand absolutely and forever barred, estopped and foreclosed from and permanently enjoined from pursuing, asserting or claiming any and all right, title, estate, interest, royalty, rental, equity of redemption or other Claim whatsoever in respect of or to the Lands, and to the extent that any such persons or entities remain in the possession or control of any of the Lands, or any artifacts, certificates, instruments or other indicia of title representing or evidencing any right, title, estate, or interest in and to the Lands, they shall forthwith deliver possession thereof to the Land Purchaser.

NATURE AND PRIORITY OF CLAIMS

17. For the purposes of determining the nature and priority of Claims, the monies payable to the Receiver under the Contract (to be held in an interest bearing trust account by the Receiver) shall stand in the place and stead of the Assets from and after delivery of the Receiver's Closing Certificate and all Claims including Encumbrances (but excluding Permitted Encumbrances) shall not attach to, encumber or otherwise form a charge, security interest, lien, or other Claim against the Assets and may be asserted against the net proceeds from the sale of the Assets with the same priority as they had with respect to the Assets immediately prior to the sale, as if the Assets had not been sold and remained in the possession or control of the person having that possession or control immediately prior to the sale. Unless otherwise ordered (whether before or after the date of this Order), the Receiver shall not make any distributions to creditors of net proceeds from sale of the Assets without further order of this Court, provided however the Receiver may apply any part of such net proceeds to repay any amounts the Receiver has borrowed for which it has issued a Receiver's Certificate pursuant to the Receivership Order.

- 18. Notwithstanding:

 - (d) the provisions of any federal or provincial statute:

the vesting of Assets in an Equipment Purchaser or the Land Purchaser, as the case may be, pursuant to this Order shall be binding on any trustee in bankruptcy that may be appointed in respect of the Debtors and shall not be void or voidable by creditors of the Debtors, nor shall it constitute nor be deemed to be a transfer at undervalue, settlement, fraudulent preference, assignment, fraudulent conveyance, or other reviewable

transaction under the BLA or any other applicable federal or provincial legislation, nor shall it constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation.

- 19. The Receiver, the Auctioneer, any Purchaser and any other interested party, shall be at liberty to apply for further advice, assistance and direction as may be necessary in order to give full force and effect to the terms of this Order and to assist and aid the parties in closing any sale of the Assets.
- 20. This Honourable Court hereby requests the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in any of its provinces or territories or in any foreign jurisdiction, to act in aid of and to be complimentary to this Court in carrying out the terms of this Order, to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such order and to provide such assistance to the Receiver, as an officer of the Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order.
